### **Old Business:**

**Second Reading of Ordinance Number 2017-03 Amending Ordinance Number 2016-06 Adopting the Fiscal Year 2016-2017 Budget for the City of Grantville, Georgia.** City Manager Al Grieshaber Jr. stated "When we passed the budget on September 12, 2016, we had certain line items in there. Revisions in the budget may be done by a majority vote by the Mayor and Council. We have found it appropriate to amend the budget, by reducing a line item and adding some monies to the line items as they are in exhibit A. There are seven various items. That remains a balanced budget; however in accordance with the Georgia Department of Revenue, your budget has to be balanced not only in total but also as to departments within the budget. So there are no overages in the budget. This budget amendment does that." Kee made a motion to adopt Ordinance Number 2017-03 Amending Ordinance Number 2016-06 Adopting the Fiscal Year 2016-2017 Budget. Second by King. 3-0
