"The GBI gets scammed by Chief Whitlock."

- 18 months later all the parts of this story were finally gathered and put together.
- The elements of a con job
 - O GA Code 16-10-20: A person who knowingly and willfully falsifies, conceals, or covers up by any trick, scheme, or device a material fact; makes a false, fictitious, or fraudulent statement or representation; or makes or uses any false writing or document, knowing the same to contain any false, fictitious, or fraudulent statement or entry, in any matter within the jurisdiction of any department or agency of state government or of the government of any county, city, or other political subdivision of this state
- GBI Agent Adam Thompson is the witness for these crimes.
 - o Former Peach Tree City detective
 - Master's degree University of West Georgia
- POST Investigator Doug Fleming is a witness for these crimes.
- Police Chief Whitlock High School grad
- How did a high school grad out smart and out use a sophisticated scheme on a veteran and highly educated GBI agent?
 - The thin blue line was implemented as a weapon (the loyalty to each other in law enforcement) by Chief Whitlock to trick the GBI into believing his version of events to eliminate all criminal liability chief Whitlock was exposed to.
 - Whitlock is a master at deception.
- Was Whitlock so convincing in his scheme to deceive the GBI that the GBI didn't even label their actions as an investigation. They labeled it "a meeting" so ensure Whitlock's name would not be entered into their criminal database as a subject of an investigation. GBI has no policy or directive on what a "meeting" is. It officially does not exist with the GBI. See how Whitlock has the knowledge of how the GBI investigation process functions. Was he able to influence the POST investigator to avoid placing his name in the title bar of any emails pertaining to him during these investigations, so a search of his name in their database would not reveal Whitlock connected to an allegation of criminal activity or wrongdoing.
- Whitlock's brother Larry Whitlock is a retired GBI agent. Did Agent Thompson work with Larry Whitlock. Does this explain any of these bizarre law enforcement omissions on Agent Thompson's behalf? Or is Agent Thompson just naïve and poorly trained and cannot detect a professional lair? Maybe Whitlock is just that good at deception.
- On October 21, 2021, Whitlock implemented his scheme to allow his friend, department chaplain and fellow church member to dress up in a uniform with a gun and badge and present himself to the public as a police officer.
- Understanding of the state law is imperative to comprehend the following facts.
 - GA Code 16-10-23: A person who falsely holds himself out as a peace officer or other
 public officer or employee with <u>intent to mislead another</u> into believing that he is actually
 such officer commits the offense of impersonating an officer.

- Investigator Doug Fleming with the Peace Officer Standards and Training Agency got involved and interviewed two witnesses and reviewed the photographic and video evidence. He referred the matter to the GBI and felt there were sufficient facts to warrant a GBI felony investigation of Chief Whitlock.
- At the end of the GBI's two hour long "meeting" with Chief Whitlock, Agent Thompson didn't bother to write a report or audio record the "meeting" with Whitlock. A police chief is accused of a felony crime and GBI doesn't feel it's important enough to record the meeting! Something is wrong here!

POST investigator Fleming did write a report and here is where Whitlock's scheme of lies and deception are uncovered.

- The city of Grantville had issued a special event permit to Tills Production Company to film in the city. That permit stated four certified police officers would be used for security and Chief Whitlock was responsible for the security plan.
- Whitlock stated he had all assigned posts covered on October 21, 2021
- According to Georgia state Code, any officer working off duty shall have a letter from the police chief or designated police official authorizing officers to work an off-duty assignment.
 - NEWLY DISCOVERED: A request for those letters was submitted and the city replied that those records do not exist. Another example of how Whitlock dances around the law for his benefit.
- Whitlock stated to GBI, two officers called in sick that morning, so he called his good friend Boyd to fill in and impersonate a police officer.
 - The City Manager wrote in an email dated prior to the discovery of the photographic evidence that officer McIntyre had called in sick that caused the manpower shortage.
 - Officer McIntyre worked that day, and he was on duty and took pictures of the crime occurring.
 - Former Grantville police officer McIntyre stated no officers called in sick the day of the incident.
 - NEWLY DISCOVERED: A request for records of officers who called in sick that day was responded to by Grantville stating those records do not exist.

Whitlock told the GBI he placed the police impersonator in view of actual officers (this doesn't exempt him from following the law).

- This was a lie. The location of the police impersonator was isolated and out of view of any law enforcement officer. Was this location purposely selected by Whitlock?
- Whitlock stated his true intent to the GBI agent. Whitlock stated he could not tell the production company he didn't have enough officers and he didn't want to delay their production. So, Whitlock presented Boyd as a police officer to trick and mislead them and the public.
 - Boyd also had an audio recorded "meeting" with GBI and told the agent he wanted to use his personal truck to for traffic control, but Whitlock

convinced him to use a police car which would have more of an influence on the public.

- No audio recording of Chief Whitlock's meeting with GBI. Why?
- Whitlock told the GBI he would not allow this kind of scenario to occur again. However, when channel 2 news, Justin Gray, interviewed Whitlock he told Gray he would do it again.
- Whitlock told GBI who would purchase magnetic signs stating "Chaplain" for the times when Boyd drives a city vehicle.
 - **NEWLY DISCOVERED:** No evidence of the purchase.

What was the reason (motive) to lie to the GBI? The alternative would have been a criminal investigation into all Whitlock's suspected criminal activity.

If any citizen gave false statements to the GBI an indictment would soon follow.
